C. Use of CDBG-R Funds

1. Description of Activities to be undertaken with CDBG-R funds:

The City intends to use the funds for public improvements and infrastructure in Railroad Square, which is adjacent to a proposed rail station and located within a City Redevelopment Area. The activity entails the removal and replacement of the existing 100-year-old 24" storm drainpipe from Wilson Street and 4th Street to a new outfall in Santa Rosa Creek. Funds will also be used for program administration.

2. Description of how the distribution and uses of CDBG-R funds will meet the requirement of Title XXII of Division A and Section 1602 of the Recovery Act:

The activity identified above is based on its ability to begin construction once the NEPA environmental review is completed. The activity will provide infrastructure improvements to the existing neighborhood, as well as serve a development project that is expected to begin construction within a year.

The activity will provide a long-term investment in the City's infrastructure, as well as provide construction jobs associated with the project.

The removal and replacement of the existing storm drainpipe in Railroad Square will assist with current service delivery and will assist future "in-fill" development located along the Sonoma Marin Area Rail Transit line.
